







# KM 105 SUNDAY 24 MAY 2026

# **RULES**

The **NOVECOLLI Gravel** is a sporting event organized by ASD GC Fausto Coppi, a regular FCI member. It is a non-competitive cycling event to be held on 24 May 2026.

### **ROUTES**

- km. 105 1.780 d+
- maximum height 436 m (Montebello)

The route will wind along dirt roads, trails and secondary paved roads.

There will be signposts along the route.

Everything as per the GPX track that will be made available a few days in advance.

#### **ADMISSIBILITY**

The event is open to all FCI and CONI-recognised organisation registered cyclists, and to all Italian and foreign non-members covered by daily insurance, upon presentation of a competitive cycling certificate pursuant to Ministerial Decree 18/02/82.

Medical certificate and/or card must be uploaded on the website www.novecolli.it by 30/04/2026.

In the case of minors (registration is possible from the age of 17 - calendar year), a release form signed by both parents or guardian is required and can be downloaded from www.novecolli.it

It is possible to take part in the event with gravel bikes, mountain bikes, e-bikes (there will be no charging stations along the route, so e-bike battery management must be autonomous).

As this is not a competitive event, there will be no final ranking.

# **REGISTRATION AND FEE**

From 5/11/2025 (12:00 a.m.) to 15/05/2026 (12:00 a.m.) online registration at www.novecolli.it payment by credit card only. Registration will only be considered valid once payment has been made. The fee is € 50.00.

On-site: on 22 and 23 May from 9:00 a.m. to 9:00 p.m. at the Nove Colli Village - Andrea Costa Square (next to the Cesenatico skyscraper). The fee is € 50.00 (no gadget).

### The fee entitles official participation in the event and includes:

- -"Nove Colli Gravel" gadget for registrations made by 12:00 noon on 15/05/2026
- -race number to be attached to the bike and back
- -route map in GPX format
- -2 refreshment stops (Sorrivoli and Montebello Castle)
- -finisher's medal
- -pasta-party at the finish (only accessible if wearing a special bracelet)
- shower service
- -guarded bike parking at the finish (only accessible if wearing both race numbers)

## **DISCLAIMERS**

Cancellations with refunds will be possible until 15/05/2026 by sending an email to iscrizioni@novecolli.it.

After this date you can only collect your race packet.

### **MEETING, DEPARTURE AND ARRIVAL**

Colonia AGIP waterfront Viale Carducci 181 Cesenatico.

Start after the last Granfondo Nove Colli grid.

You must be on the grid by 6:15 a.m.

#### **ITINERARY**

Cesenatico, Carpineta, Sorrivoli, Longiano, Savignano, Masrola, Torriana, Montebello, Santarcangelo, Bellaria, Cesenatico.

Maximum time for completing the course: 12 hours

#### **RACE PACKET COLLECTION**

Nove Colli Village - Andrea Costa Square (adjacent to the Cesenatico skyscraper) Friday 22/05 and Saturday 23/05 from 9:00 a.m. to 9:00 p.m.

IT IS MANDATORY TO PRINT OR DOWNLOAD ON YOUR SMARTPHONE/TABLET from www.novecolli.it the RACE PACKAGE RECEIPT DOCUMENT to be presented in order to receive the material required for the race.

The procedure for printing/downloading this document can be carried out by accessing the 'Verify your registration' area after logging in.

The race pack may also be picked up by third parties, on presentation of the above mentioned document downloaded from the website.

# **PARTICIPANTS' RESPONSIBILITIES:**

# **Compulsory equipment**

The display of the race number on the bike and on the back in a visible and unaltered manner is mandatory. The number must not be rolled up.

The competition number is strictly personal and non-transferable to third parties, under penalty of immediate exclusion from the event.

Participants without a bib number and/or with another person's bib number have no insurance cover and may be legally punished in the event of an accident.

We remind you that the exchange of bib numbers constitutes a criminal offence.

### Minimum safety equipment:

Participants are obliged to carry the following minimum safety equipment with them for the duration of the event

- -GPS device and/or smartphone with GPS functionality with sufficient power reserve to complete the route
- -approved helmet to be worn at all times
- -repair kit (multitool) and puncture repair kit (inner tube and/or patches, levers, pump and/or inflator)
- -suitable clothing

# **GENERAL RULES AND WARNINGS**

The organiser is relieved from any liability connected with the holding of the event and, in particular, from

- -accidents occurring to participants or caused by participants
- -losses on the route by participants
- -accidents of any kind suffered by participants
- -any damage to participants' bikes
- -thefts occurring to participants

# By registering for the event, the participant acknowledges:

- -to be aware that the trails are not fully signposted, so it is necessary to refer to the GPX tracks
- -that he or she travels at his or her own risk and is considered to be on a free personal excursion with no extra rights compared to other trail and road users
- -that there is no mechanical assistance service provided by the organisers along the route, nor is there a recovery service for those who have retired and their vehicles
- -that there is no obligation on the part of the organisers to search for participants on the route and that he/she undertakes to inform the organisers of his/her withdrawal by calling or sending a text message to the telephone number indicated by the organisers.

By giving their consent by completing and submitting the online registration form, each participant guarantees his/her own conduct during and after the event; he/she also declares that he/she is in good physical condition and in possession of a valid membership card and medical certificate on the date of the race; that he/she has read and approved the following regulations.

This consent form is legally binding of self-certification in relation to what has been declared.

The Participant agrees to release G.C. Fausto Coppi from all liability of the organisers and collaborators, for accidents or damage to persons or property (including those left unattended), which may occur before, during and after the event or as a result of the event.

It should be noted that the event takes place, in part, on roads open to traffic and therefore all participants are obliged to respect the highway code.

The event will take place in all weather conditions.

#### Participants are also required:

- -adequate physical preparation for the chosen route
- -a good knowledge in the use of GPS and orientation
- -to assist anyone in difficulty along the route

-to respect and keep clean the places crossed, avoiding littering along the route and disposing of it in the appropriate collection containers.

For anything not covered by these regulations, the general rules of the F.C.I. National Amateur Sector and U.C.I. provisions apply.

The G.C. Fausto Coppi reserves the right to exclude athletes who misbehave before, during and after the event.

#### **CANCELLATION OF EVENT**

If, due to force majeure or an event beyond the organisation's control, the event does not take place, the participation fee will neither be refunded nor considered valid for the following year. However, the right to participate in the next edition will be recognised: this right must be exercised by means of a new regular registration with payment in accordance with the regulations.

In addition, if, due to force majeure or an event not attributable to the organiser, the event should not take place on the set date, but could be rescheduled to a later date in the current year, the organiser reserves the right to inform the entrants of the new date of the event, without a minimum period of notice; in this case, each entrant shall have the option to take part in the event on the new date, without any further charges, except for any administrative charges that may be communicated, or of retaining the right to take part in the next event, in which case making a new entry with regular payment, as provided for in this article.

#### **VARIATIONS**

The organisation reserves the right to make any changes to the route and regulations at any time. The website www.novecolli.it is the official information organ of the event, therefore all official announcements will be made on the website.

# **SIGNATURE – TRANSFER OF IMAGE AND DATA RIGHTS**

By submitting the online registration form, participants who are of legal age or, if minors, those who exercise parental authority or act on their behalf, responsibly declare that they possess a valid cycling licence and/or medical certificate, that they have read and unconditionally accept each article of these regulations and also express consent to the use of data, as provided for by the Privacy Law (Article 13 of EU Regulation 679/2016 – GDPR).

By submitting the online registration form, the participant authorises A.S.D. Gruppo Cicloturistico Fausto Coppi to transfer their personal contact details to third parties for promotional purposes.

By submitting the online registration form, participants also give their consent for photographs, video recordings, audio recordings of any kind and type, concerning them during the event, to be freely stored, reproduced, published and disseminated by the Organisation A.S.D. Gruppo Cicloturistico Fausto Coppi and its sponsors, without claiming any right to compensation and/or indemnity. Participants also expressly authorise the Organisation, sponsors, together with their media partners and tourism promotion agencies, to use still or moving images depicting them during their participation in the race on all media, including cycling promotion and/or advertising materials. Participants consent to such data and related material being made available to professional photographers and/or photo studios specifically appointed by the organisation to provide photographic services for the Race.

Use and processing of personal data refers to any operation or set of operations involving the collection, recording, organisation, storage, consultation, processing, modification, selection, extraction, comparison, use, interconnection, blocking, communication, dissemination and distribution of data, even if not recorded in a database pursuant to Article 7 of Legislative Decree No. 196/2003.

# **EXCLUSION OF LIABILITY**

By applying to take part in the event, each participant declares that he/she has read and approved these regulations and accepts each and every part of them.
