



# SHORT COURSE - KM. 60

## REGULATION

The event is open to all FCI/UCI members and members of organisations recognised by CONI, to all non-members from Italy and abroad with a non-competitive medical certificate and to E-bikes.

### **Registration and Fee**

From 13/12/2023 at 10:00 a.m. to 30/04/2024 at 08:00 p.m. online registration at [www.novecolli.it](http://www.novecolli.it) payment by credit card only. Registration will only be considered valid once payment has been made.

The fee is **€ 90.00 (ninety)** until the closing date for entries on 30/04/2024.

The fee includes: "Nove Colli" gadget, pasta-party at the arrival (accessible only if provided with a special bracelet), mechanical and medical assistance, 2 refreshments, shower service, guarded bike parking at the arrival (accessible only if provided with both race numbers), participation diploma.

### **Permitted e-bikes and technical characteristics**

The types of motorisation accepted are those defined by law as velocipedes and not mopeds, i.e. with 250 watt motors and batteries that can be from 300 Wh up to 750 Wh, the only difference being the battery life. **Spare batteries are permitted.**

- a) E-BIKE models with motorisation characteristics exceeding 250 watts with a maximum speed in assistance of 25 km/h are not permitted after this speed the motor must, as per law, automatically switch off (type approval directive of 2002/24/EC).
- b) All industrially manufactured pedal-assisted E-BIKES are therefore allowed.

There will be no charging stations along the route, so battery management will have to be autonomous.

### **Substitutions and Cancellations**

Substitutions and cancellations possible until 30/04/2024.

The fee is non-refundable, after this date it is only possible to collect the race package.

### **Meeting, Departure and Arrival**

Colonia AGIP lungomare - Viale Carducci 181 – Cesenatico.

Start at 7.00 a.m. Green grid.

### **Participation and checks**

Checks will be carried out with a stamp, at appropriately marked points. Timekeeping is not foreseen, nor is the use of chips with ranking.

The participant must observe all control points at the start and along the route, using only the stamped card.

Maximum time for completion: arrival by 19:00 hours.  
The route and controls are all appropriately signposted.

Minors will be required to provide a specific release form signed by their parent or guardian, which can be downloaded from the [www.novecolli.it](http://www.novecolli.it) website.

Medical certificate and/or membership card must be uploaded on the [www.novecolli.it](http://www.novecolli.it) website by 30/04/2024.

### **Route**

Cesenatico, Villalta, Sala, S. Angelo, Savignano, Borghi, Sogliano, Savignano, Gatteo, Fiumicino, Sala, Cesenatico (arrivo viale Carducci presso colonia "Agip").

### **Race packet collection**

Nove Colli Village – Ciclo & Vento Expo, Piazza Andrea Costa (next to the skyscraper of Cesenatico)

Thursdays 16/05 from 2 p.m. to 10 p.m.; Friday 17/05 and Saturday 18/05 from 9 p.m. to 10 p.m.

**It is MANDATORY TO PRINT OR DOWNLOAD on smartphone/tablet from the website [www.novecolli.it](http://www.novecolli.it) the DOCUMENT FOR THE RACE PACK COLLECTION to be presented in order to receive the necessary material for the race.**

The procedure to print this document can only be carried out by the person who did the pre-registration, using your Username and Password in the Login area.

The race number and chip is strictly personal and cannot be given to third parties. If this happens disqualification is immediate.

Participants without a bib and/or with another person's bib do not have insurance cover and may be legally punished in the event of an accident.

**Remember that the exchange of bibs is a criminal offence.**

### **General rules and warnings**

**The use of a helmet is compulsory** and it is essential to have a repair kit for breakdowns and punctures.

For what is not addressed in these regulations, the general regulations and rules of the National Amateur Sector F.C.I. and U.C.I. orders must be applied.

The G.C. Fausto Coppi, in compliance with the regulatory determinations in the field of safety, has applied for and obtained the authorisations prescribed by local regulations and the Highway Code.

The participant exonerates G.C. Fausto Coppi from any liability for damage to persons or property resulting from the condition of the road surface.

Pursuant to and for the purposes of Articles 1341 and 1342 of the Italian Civil Code, the Participant declares that he/she has carefully examined all the clauses contained in the organisers' disclaimer and specifically approves all the points listed therein."

The G.C. Fausto Coppi declines all responsibility, for itself and its staff, with regards to accidents or injuries or theft or damages before, during and after the race or caused by the event itself. Furthermore the G.C. Fausto Coppi reserves the right to exclude all athletes behaving incorrectly before, during or after the race. Furthermore, all participants who throw litter or any other objects outside the designated areas at the refreshment stops will not be allowed to register or participate for the following year's event.

We advise that for a correct and safe execution of the event, the data of the vehicles who illegally follow the participants and who transit in the blocked off areas or in the space between the race start and race finish, will be recorded by the organisation inspectors and given to the Jury and to the local police for any eventual sport or legal measures to be taken.

Attach your race number in a visible place on, and not rolled round, your handlebars, and the shirt number on your back..

### **Cancellation of the event:**

If due to force majeure or an event not attributable to the organization, the event does not take place, the amount of the participation will neither be refunded nor considered valid for the following year. However, the right to participate in the next edition will be recognized: this right must be exercised through a new regular registration with payment as per regulation.

Furthermore, if due to force majeure or an event not attributable to the organization, the event does not take place on the set date, but could be rescheduled for a later date of the current year, the Organizer reserves the right to communicate to the members the new date of the event, without minimum notice terms; in this case, each member will have the right to opt for participation in the edition on the new date, without further charges, except for any administrative charges that may be communicated, or to maintain the right to participate in the next edition, in this case by making a new registration with regular payment, as provided for in this article.

### **Variations**

The organization reserves the right to change the regulations or route if necessary. All official communications will be notified on the website [www.novecolli.it](http://www.novecolli.it)

**In order to protect the environment, it is absolutely forbidden for participants to throw rubbish of any kind along the roads, placing it only in the appropriate containers located near the refreshment posts and/or at the finish line.**
