

# **48<sup>th</sup> GRANFONDO NOVE COLLI – SELE ITALIA**

## **E-BIKE PARTICIPATION**

### **1) Meeting point and departure:**

Touristic Harbour of Cesenatico. Meeting time: 6:00 a.m. Start from the dedicated **ELECTRIC GRID**, after the last official Grid.

E-bike participants are excluded from the competition as they are included in the space delimited by the vehicles "end of the race" and "end of the event", and also outside of merit rankings, **therefore they are required to pass exclusively cycle-tourism** in compliance with all the rules governing normal road traffic.

### **2) Participation:**

The event is open to **EVERYONE** (from 18 years old).

The participants will be in possession of the F.C.I. or agencies of the National Council.

**Foreign athletes** must be in possession of a card recognized by the UCI (the cyclists coming from foreign federations with a card recognized by the UCI can participate after signing the "Ethical Declaration" downloadable in the "DOWNLOADS" section on the Nove Colli website).

Cyclists participating in the event with e-bikes can perform **EXCLUSIVELY the route of 131km.**

For non-members it is compulsory to send by fax to 0547 672186 the **agonistic sporting certificate specific for the cycling discipline** (The certificate is to be sent at the time of registration and in any case no later than 07/05/2018)

**We remind that the certificate sent must necessarily be valid at the date of the event.**

Registration requests will not be accepted by athletes who have been subjected to doping penalties by sporting and/or ordinary justice and those who have a disqualification underway in a Granfondo between Marathon of the Dolomites, Nove Colli, Sportful Dolomiti Race of Feltre, Granfondo Pinarello Cycling Marathon of Treviso, Felice Gimondi of Bergamo.

### **3) The organization reserves the right to cancel incomplete registration.**

### **4) Bicycles allowed and technical features:**

The types of motorization accepted are those according to law for which defined as velocipedes and not mopeds or with 250 watt motors and batteries that can be 300 kwh and 400 kwh whose only difference is only in the battery life.

- a) Not allowed E-Bike which has engine characteristics above 250 watts with maximum speed in assistance of 25Km/h speed counting
- b) All E-Bikes with assisted pedalling are allowed of industrial production, for which it is obligatory to show the conformity. Without it the cyclist can not take part in the event.
- c) Only bicycles with quick release pedals are permitted

## **5) Pre-Registration, registration:**

From **03/05/2018 to 06/05/2018** – in order to facilitate the registration procedure – it will be possible to proceed with the insertion of data for individual athletes or teams.

**Click day: 07/05/2018 (€ 50,00) AT 12:00 PM, with 48 entries available.**

The Nove Colli E-Bike event is on registration and is bound to reach a **maximum of 48 members**. The Organizational Committee may at any time, and at its sole discretion, decide whether or not to accept the registration or exclude a member from the event if it may damage the image of the same. **Registration must be completed on-line only using the appropriate form on the website [www.novecolli.it](http://www.novecolli.it).**

## **6) Participation fee:**

**On 07/05/2018 participation fee is € 50,00.**

The fee includes: daily SMS chip with Winning Time technology, gadget "Nove Colli-Selle Italia", pasta party on arrival (accessible only if equipped with a special bangle), mechanical and medical-health assistance, radio-rescue, 3 supplies on the route of km. 131, shower service, pasta party, bike parking guarded on arrival (only accessible if equipped with both race numbers), souvenir object, graduation downloadable from the site [www.novecolli.it](http://www.novecolli.it).

## **7) Condition of payment:**

- 1. BANK TRANSFER** (to be made only from the day following registration) at the Banca Popolare Emilia Romagna branch of Cesenatico IBAN IT 44 V 05387 24000 000000978664 - SWIFT (BIC) BPMO IT 22 at the expense of the sender payable to: ASD G.C. Fausto Coppi, Via Saffi c / o Stadio Comunale, 47042 Cesenatico (FC), **indicating the pre-registration code** (received by e-mail), **sending a copy of the payment within 2 days from the completion of the online form**, to the fax number 0547 672186 (after this period registration will not be guaranteed).

Make a bank transfer for each pre-registration code.

- 2. CREDIT CARD** through the Internet site [www.novecolli.it](http://www.novecolli.it) only **possible from the following day and within 2 days from the completion of the on-line form** (by performing this procedure, it is not necessary to send any documentation by fax).

## **8) Recesses or Cancellation:**

Cancellations or substitutions will not be accepted. Who cannot participate, only if requested by e-mail, will receive the gadget at home with shipping costs against him.

**The fee is not refundable.**

## **9) Check card ad race pack pickup:**

In Cesenatico at Saffi street in the city stadium  
from thursday 17/05 ore 9.00/12.00 (am) – 3:00/06.30 (pm)  
friday 18/05 and saturday 19/05 from 9:00 am to 8:00 pm

**It is mandatory to download the document for the pick-up of the race pack on the site [www.novecolli.it](http://www.novecolli.it), presenting it to the delivery of it.**

The procedure for printing this document can only be performed by the holder of the pre-registration, using the "User Name" and "Password" used to register, **in the Login area of the Nove Colli website**. Withdrawals from third parties are accepted only by submitting the aforementioned document.

**The race number and the chip are strictly personal and not transferable to third parties, under penalty of immediate expulsion from the event and disqualification for the following year.**

**Participants who do not have race number and/or race number of another person do not have insurance coverage and can be legally punished in the event of an accident.**

**10) Route and maximum time:**

130km route to be completed in 7 hours. Cesenatico, Martorano, Diegaro, Forlimpopoli, Bertinoro, Polenta, Fratta, Meldola, Pieve di Rivoschio, S. Romano, Ciola, Mercato Saraceno, Barbotto, Sogliano, Borghi, Savignano, Gatteo, Sant'Angelo, Cesenatico (arrivo viale Carducci presso colonia "Agip").

**11) Club awards:**

The most numerous E-Bike team will be awarded.

**12) Medical assistance:**

It provides for the use of ambulances with doctors, motorcycles with qualified paramedical staff following the race, fixed First Aid points, one of which is permanent in the arrival area. Fixed and mobile points of Radio Relief.

**13) Mobile and mechanical assistance:**

Fixed points of assistance and mobile points with cars and motorcycles are dislocated.  
**Get a self-repair kit**

**IMPORTANT:**

**The organization will not take charge of the recovery of the E-Bike and the cyclist that will remain "discharge" of the battery.**

**The cyclist must be in physical training to stand up to 130 km with a difference in height of 1871m.**

**14) Helmet:**

Helmet its compulsory and must be approved.

**15) Insurance:**

The event is assured by the F.C.I. ([www.feder ciclismo.it](http://www.feder ciclismo.it)) and is also covered by the supplementary policy Assofondo ([www.assofondo.it](http://www.assofondo.it)). Non-registered cyclists must not

enter the group, under penalty of expulsion. In the event of an accident, they will be reported according to the law.

**The accident cyclist will have to report to the institution he belongs to his own company.**

## **16) Standards:**

For anything not covered in this regulation, the general rules of the National Amateur Structure F.C.I. and provisions U.C.I. G.C. Fausto Coppi declines all responsibility for himself and his collaborators, for accidents or damage to persons or property, which may occur before, during and after the event or as a result of the same.

**It reserves the right to exclude athletes who will behave incorrectly before, during and after the even .**

**Competitors who throw waste and objects of any kind outside the appropriate spaces located in the refreshment areas and along the route, will be subject to disqualification for the current and subsequent editions.**

It is noted that for a correct and safe performance of the competition, the data of vehicles that abusively follow the competitors and transit in the space **forbidden to normal circulation, or in the space between the start and the end of the race**, will be detected by the inspectors of the 'organization and handed over to the jury and the competent police authority, for any measures both sporting and infringing the Highway Code.

## **17) Sanctions:**

In the case of POSITIVITY at anti-doping controls in the Granfondo Nove Colli, or positive in the following six months the Granfondo, in other sporting events, the competitor is required to pay the Organizing Committee Nove Colli, as compensation for the serious damage caused to the image of the event, the sum of € 50,000.00 (fifty thousand euros / 00).

If belonging to a sports association, the latter will be solidly obliged to pay this penalty. The sums that will be confiscated by the Organizing Committee of the Granfondo Nove Colli, as compensation for the damage to the image, will be entirely devolved to youth sports activity.

## **18) Complaints:**

Any complaints must be received by the jury in accordance with the regulatory terms accompanied by the tax provided under the regulations of the F.C.I.

## 19) Cancellation of the event:

If due to force majeure or any other event not attributable to the organization, the event does not take place, **the amount of the participation will not be reimbursed or considered valid for the following year**. However, the right to participate in the 2019 edition will be considered valid, which must be exercised through a new regular registration with payment as per regulation.

The validity of the aforementioned registration right is only for the year following the cancellation of the event and is nominal and not transferable to third parties.

## 20) Variations:

The organization reserves the right at any time to prepare any changes to the route and the rules.

**The website [www.novecolli.it](http://www.novecolli.it) is the official information body of the event, therefore all official communications will be announced on the site.**

## 21) Signature:

By signing the online registration form you declare to be in possession of a regular card and / or medical certificate, to have read and to accept the present regulation and express the consent of the use of the data, as required by the law on Privacy n. 196 of 30/06/2003. By signing and submitting the online registration form, the participant also expresses his consent, so that any photos, videos, audio and / or video recordings, of any kind, produced on the occasion of the "Granfondo Nove Colli" can be freely memorized, reproduced, published and marketed by the ASD Organization FAUSTO COPPI CYCLING GROUP, to which it transfers all related rights free of charge and, therefore, without any claim to any resulting compensation and / or indemnity in favor of the participant. Moreover, and in any case, the participant expressly authorizes the A.S.D. FAUSTO COPPI CYCLING GROUP, together with its partner media, to use the still or moving images that eventually portray it during its participation in the competition, on all media, including promotional and / or advertising materials. The participant therefore consents that the A.S.D. FAUSTO COPPI CICLOTURISTICO GROUP transfers this data and this material in favor of photographers and / or photos of professional studios specifically appointed by the Organization for the creation of photographic services on the race.
