

**1st INTERNATIONAL GRANFONDO**  
**NOVE COLLI – E POWER ON 19/05/2019**

**1) Departure**

Grouping at 6 am – Departure of the Electric Grid is 10 minutes after the GREEN grid has departed.

**2) Participation:**

The race is open to everyone (18 years of age or over), except for professionals, Elites (men and women) and the Under 23s. They are admitted only on a promotional basis and if invited by the Event Organizers.

Italian participants should possess an FCI race license or a license of an organization that has a bilateral subscription with FCI.

**Foreign athletes** must have a UCI recognized race license (amateur cyclists who come from foreign federations and have UCI recognized race licenses can take part providing they have signed the 'Ethical Declaration' which can be downloaded in the 'DOWNLOAD' section on the [www.novecolli.it](http://www.novecolli.it) website.

Amateur and Leisure cyclists of 19 years above (solar year) can **ONLY** take part in the 96km route.

For non-license holders, it is mandatory to have a medical certificate for competitive sports, specifically for the cycling discipline (the certificate is to be uploaded on the site [www.novecolli.it](http://www.novecolli.it) through the upload procedure, in order to regularize the participation).

**Remember that the certificate must be valid at the date of the event.**

Registration requests will not be accepted from athletes who have suffered penalties for doping from sporting and / or ordinary justice and those who have a disqualification underway in one of the following Granfondos: Marathon of the Dolomites, Novecolli, Sportful Dolomiti Race of Feltre, Granfondo Pinarello Cycling Marathon of Treviso, Felice Gimondi of Bergamo.

**3) The organization reserves the right to cancel incomplete registrations.**

**4) Bicycles allowed and technical features:**

The types of motorization accepted are those in appliance to the law and defined as velocipedes and not mopeds or with 250 watt motors and batteries that can be from 300 Wh up to 750 Wh whose only difference is in the battery life. Spare battery is allowed.

a) E-BIKE models that have engine characteristics above 250 watts with maximum service speed of 25Km / h or more are not allowed. The engine must be deactivated automatically by law (2002/24 / EC approval directive).

b) All pedal assisted E-BIKES, of industrial production, are therefore admitted.

**5) Pre-registration, registration and waiting list**

From 10/03/2019 to 18/03/2019 in order to speed up the registration process, it will be possible to pre-register the data of the individual athletes or teams.

Registration open: 19/03/2019 from 10.00

The Nove Colli Organization may at any time, and at its sole discretion, decide whether or not to accept the registration or exclude a member from the event if it can damage the image of the same. The Nove Colli Organization reserves the right to close the registration in case of high numbers.

Entries must be completed exclusively online using the appropriate form on the website [www.novecolli.it](http://www.novecolli.it)

#### **6) Participation fee:**

**on 19/03/2019 the fee will be € 50.00.**

**From 00:01 of 20/03 to 30/04/2019 will be € 85.00**

The fee includes: daily SMS chip with Winning Time technology, "Nove Colli E-Power" gadget, pasta party on arrival (accessible only if equipped with a special bracelet), mechanical and medical-health assistance, radio-rescue, 2 refreshment stops on the route of km. 95, shower service, pasta party, Secure bike park on arrival (only accessible if equipped with both race numbers), souvenir object, diploma downloadable from the site [www.novecolli.it](http://www.novecolli.it).

#### **7) Payment Method:**

Make one bank transfer for each pre-registration code.

2. Credit card through the website [www.novecolli.it](http://www.novecolli.it) within 5 days from the completion of the on-line form (if you pay by credit card, it is not necessary to send any documentation by fax).

#### **8) Recesses or cancellations:**

Cancellations or substitutions will not be accepted. Who cannot participate, only if requested by e-mail, will receive the gadget at home with shipping costs at his/her expense.

The registration fee is non-refundable.

#### **9) License check and race pack pick-up**

In Cesenatico in Via Saffi c / o Stadio Comunale

on 16/05 from 9.00 - 12.00 and 15.00 - 18.30, on Friday 17/05 and Saturday 18/05 from 9.00 - 20.00

It is mandatory to download the document for the pick-up of the race pack from the site [www.novecolli.it](http://www.novecolli.it) and hand it in when you pick up the pack.

The procedure for printing this document can only be performed by the holder of the pre-registration, using the "User Name" and "Password" used to register, in the Login area of the [www.novecolli.it](http://www.novecolli.it) website

Race packs will be given to third parties only by submitting the aforementioned document.

**The race number and the chip are strictly personal and not transferable to third parties, under penalty of immediate expulsion from the event and disqualification for the following year.**

**Participants who do not have their own number or are using a number registered in another name do not have insurance coverage and can be legally punished in the event of an accident.**

**10) Route and maximum time:**

**Route 95 km:** to be completed in maximum 7:00 hours. Cesenatico, Martorano, Diegaro, Forlimpopoli, Bertinoro, Collinello, San Vittore, San Carlo, Gualdo, Bivio Ponte Giorgi, Santa Maria Rio Petra, Strigara, Sogliano, Villages, Savignano, Gatteo, Sant'Angelo, Cesenatico (arrival in viale Carducci near colonia "Agip").

**11) Awards and rankings:**

The first 3 most numerous electric teams will be awarded.

**Individual rankings will not be compiled**

**12) Health care:**

Ambulances with doctors, motorcycles with qualified paramedical staff following the race, fixed points of First Aid, one of which is permanent in the arrival area. Fixed and mobile points of Radio Relief will all be provided.

**13) Mobile and mechanical assistance:**

Fixed points of technical assistance and mobile points with cars and motorcycles are provided (spare parts are not included).

Take a self-repair kit.

**IMPORTANT:**

**The organization will not be responsible for the pick-up of the bike or rider should they be left stranded due to the battery running out.**

**14) Helmet:**

Mandatory and in appliance to the law.

**15) Insurance:**

The event is assured by the F.C.I. ([www.feder ciclismo.it](http://www.feder ciclismo.it)) and is also covered by supplementary policy Assofondo ([www.assofondo.it](http://www.assofondo.it)). Non-registered cyclists cannot take part in the event under no circumstances, with the penalty of expulsion and in case of an accident, they will be reported according to the law.

The cyclist involved in the accident must **report it to the association or organization he belongs to.**

## **16) Rules:**

For anything not covered by these regulations, the general rules of the National Amateur Structure F.C.I. and provisions U.C.I. apply. G.C. Fausto Coppi declines all responsibility for itself and its collaborators, for accidents or damage to persons or property, which may occur before, during and after the event or as a result of the same.

It reserves the right to exclude athletes who behave incorrectly before, during and after the event.

In addition, competitors who throw waste and objects of all kinds outside the appropriate spaces located in the refreshment areas and along the route, will be subject to disqualification for the current and subsequent editions.

## **17) Sanctions:**

In the case of positive anti-doping controls in the Granfondo Nove Colli, or positive in the following six months the Granfondo, in other sporting events, the competitor is required to pay the Organizing Committee Nove Colli, as compensation for the serious damage caused to the image of the event, the sum of € 50,000.00 (fifty thousand euros / 00).

If he/she belongs to a sports association, the latter will be solidly obliged to pay this penalty.

Any sum confiscated by the Organizing Committee of the Granfondo Nove Colli, as compensation for the damage to the image, will be entirely devolved to youth sports activity programmes.

## **18) Complaints:**

Any complaints must be received by the jury in accordance with the regulatory terms accompanied by the foreseen fee under the regulations of the F.C.I.

## **19) Cancellation of the event:**

If, due to uncontrollable and unforeseen circumstances, or any other event not attributable to the organization, the event does not take place, the amount of the participation fee will not be reimbursed or considered valid for the following year. However, the right to participate in the 2020 edition will be considered valid, which must be exercised through a new regular registration with payment as per regulation.

The validity of the aforementioned right to register is only for the year following the cancellation of the event and is nominal and not transferable to third parties.

## **20) Variations:**

The organization reserves the right at any time to make any changes to the route and the rules.

The website [www.novecolli.it](http://www.novecolli.it) is the official information centre of the event, therefore all official communications will be announced on the site.

## **21) Signature:**

By signing the online registration form, you declare that you are in possession of a regular license and / or medical certificate, that you have read and accepted these rules and express your consent to the use of data and images, as per EU Regulation 679 / 2016 - GDPR
